

Continuing Professional Development Credits – Free Programs for 2011

As you know, every lawyer must complete 12 hours of Continuing Professional Development credits (“CPD credits”) activity every year. Three hours of these credits must include a “professionalism” component which is comprised of professional responsibility, ethics and/or practice management.

For members of the profession in their first two years of practice, only CPD activity accredited by the Law Society (called New Member accreditation) will count towards the 12 hour requirement.

In an effort to ensure that everyone obtains the 3 hours of “professionalism” content, here is a list of **free** programs that are being broadcast live, online or via teleseminar by the LSUC.
